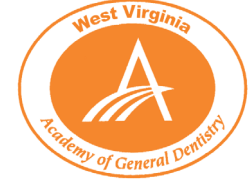

**“Medical Emergency Prevention and Management for the Dental Professional” - Friday 8:00am - 11:00am**

This course will provide information on the prevention and management of common medical emergencies in the dental office. Emphasis will be placed on medical history review and clinical decision making for the entire dental team.

Michelle G. Klenk RDH EdD is currently serving as Department Chairperson of the Bridgemont Community and Technical College Dental Hygiene Program (Formerly WVU Tech) She recently completed 3 years of service on the West Virginia Board of Dental Examiners and also continues to serve as a dental hygiene member/examiner of regional board organizations NERB, SRTA and CITA.

Dr. Klenk earned her dental hygiene bachelor’s degree from WVU, a Master’s degree in Dental Auxiliary Education from the University of North Carolina at Chapel Hill and a doctorate in Education Administration from WVU. She is a consultant and continuing education presenter in the dental field specializing in the areas of OSHA/Infection control, Substance Abuse, Medical Emergencies and Medically Compromised patients. Dr. Klenk is a current member and past president of the West Virginia Dental Hygienists Association.



**Carol A. Spear, BSDH, MS**

**“A Review of Infection Control and Safety Guidelines for the Dental Professional” - Friday 11:00am - 1:00pm**

This course will provide an overview of current infection control protocol for the dental health care provider. In addition, emerging infectious diseases and their management and technology to reduce the risk of exposure to the patient, dental practitioner, and employee will be discussed.

Attendance in this course will fulfill the requirement of two (2) hours of continuing education in infection control for both dental and dental hygiene license renewal for the two-year reporting period in WV.

**COURSE OBJECTIVES:**

1. To review OSHA mandates and CDC Guidelines for the practice of dentistry.
2. To inform dental professionals of technology to reduce risk of blood borne disease exposure to the patient, employee, and dental practitioner.

Carol Spear recently retired as a Professor at West Virginia University School of Dentistry, Division of Dental Hygiene after having served for 34 years as a faculty member. She also taught in the Department of Dental Hygiene at Foothill Community College in Los Altos Hills, CA for seven years. She holds a Bachelor of Science degree from West Virginia University and a Master of Science degree from The University of Michigan. Carol has presented numerous lectures and continuing education courses on infection control and bloodborne pathogens during her tenure at WVU and was Chair of the Committee on Infection Control. Although retired from teaching, Carol continues her interest in dental infection control and is an active member of OSAP (Organization for Safety and Asepsis Procedures).

She has authored chapters in four textbooks, served as an exam writer for the Dental Hygiene National Board Exam, was selected as an Outstanding Teacher at the WVU School of Dentistry, and was the recipient of the 2001 WVU School of Dentistry Alumni Association Distinguished Alumni Award and the 2009 WVDHA Distinguished WV RDH Award. Carol is also a member of the American Dental Hygienists’ Assoc., West Virginia Dental Hygienists’ Assoc., American Dental Educators’ Assoc., Sigma Phi Alpha National Dental Hygiene Honorary, the WVU School of Dentistry Alumni Association, and the WVPFA. She has also served as a member of the WVU School of Dentistry Alumni Association Board of Governors.

Carol holds dental hygiene licensure in WV, CA, and VA and a General Supervision Permit in WV. She is also certified in local anesthesia in both CA and WV.
