Dear Senator Durbin:

On behalf of the Organized Dentistry Coalition (ODC), we write to express our sincere appreciation for your leadership in advancing oral health and for introducing S. 4008, the *Promoting Dental Health Act*. Your longstanding commitment to improving access to oral health care and strengthening public health infrastructure has made an important difference for communities across the country.

Good oral health is essential to overall health and well-being, yet oral disease remains one of the most common chronic conditions in the United States. As outlined in materials supporting this legislation, more than 50 percent of children and more than 25 percent of adults have cavities, nearly 70 million Americans do not have dental insurance, and 64 million people live in Dental Health Professional Shortage Areas.

The Centers for Disease Control and Prevention's Division of Oral Health (CDC DOH) plays a critical role in helping states and communities address these challenges through oral health surveillance, school sealant programs, workforce development, public education, and initiatives that support prevention and integration of oral health within broader health systems. These public health strategies complement clinical care and help prevent disease before it begins, particularly for children, families, and communities facing the greatest barriers to care.

The *Promoting Dental Health Act* would reauthorize the CDC DOH for five years, helping sustain and extend evidence-based efforts to improve oral health nationwide. Continued federal support for this work is especially important because the program currently funds only a limited number of states, and some states have not received this core public health support in decades.

This legislation is an important investment in public health infrastructure. Strong state oral health programs are essential for surveillance, prevention, school-based programs, workforce coordination, public education, and cross-sector partnerships that improve health outcomes and reduce long-term costs.
