**RE:** Floor Consideration of the *PREVENT HPV Cancers Act of 2021 (H.R.1550)*

Dear Speaker Pelosi and Minority Leader McCarthy:

On behalf of the Academy of General Dentistry's (AGD) 40,000 members and the AGD Foundation, we respectfully request that you consider permitting H.R.1550, the *Promoting Resources to Expand Vaccination, Education and New Treatments for (PREVENT) HPV Cancers Act of 2021*, to be brought to the House floor for a vote. We would also request that you urge your respective caucus and conference to support the bill's passage unanimously.

H.R.1550 was reported favorably out of the House Energy and Commerce Committee by a unanimous voice vote on July 21.

We strongly support this bipartisan legislation and its provisions to promote public awareness of human papillomavirus (HPV) vaccines, which can prevent HPV and cancers associated with HPV. The bill would also reauthorize and enhance Johanna's Law, an existing CDC program to prevent and increase awareness of all HPV-associated cancers.

General dentists are the first line of defense against oral cancer. At biannual visits, dentists may examine patients' mouths for irregularities and unusual growths. If a growth is suspicious, the dentist will refer the patient for appropriate testing and/or treatment. Cancer is always best treated at its earliest stage – screening for cancer regularly benefits patients' functionality and decreases the costs of treating advanced-stage cancers. HPV is believed to cause 70% of oropharyngeal (throat and mouth) cancers in the U.S. each year, which is estimated to be approximately 14,000 instances of cancer.<sup>1</sup>

We believe the *PREVENT HPV Cancers Act* will make great strides towards improving oral cancer awareness and prevention through its direct emphasis on promoting awareness of HPV vaccines and HPV-related cancers. AGD and the AGD Foundation
