Dear Representatives Lawrence, Balderson, Quigley, and Joyce:

On behalf of the Academy of General Dentistry (AGD) and its 39,000 members, I would like to thank you for your efforts to support small businesses dealing with the impacts of the 2019 novel coronavirus (COVID-19) by introducing H.R.7216, the Small Business Personal Protective Equipment (PPE) Tax Credit Act. We strongly support H.R.7216 and its provisions to provide a tax credit, up to \$25,000, for gualified personal protective equipment (PPE) expenses incurred by small businesses, including dental practices, for the purpose of reducing the risk of COVID-19 transmission.

As you know, many dental practices closed entirely or for all but emergency services during the height of the COVID-19 pandemic. Now, many dentists are in the process of reopening their offices to provide oral health care in the communities they serve.

However, in order to deliver care in a manner that provides the highest level of safety for patients, staff, and themselves, many dentists have needed and will continue to incur substantial costs related to implementing enhanced infection control measures. The costs associated with adopting these health and safety measures are having an enormous financial impact on these small business dental practices. This is in part due to the fact that many dental benefit plans do not currently reimburse dentists for the use of enhanced PPE.

AGD is pleased that the tax credit created by H.R. 7216 would provide our small business dental practices would help mitigate a portion of costs they will assume in procuring qualified personal protective equipment expenses the Treasury Secretary, in consultation with the Secretary of HHS, determines necessary for the purpose of reducing the risk of COVID-19 transmission between people in the dental setting. The majority of small business dental practices across the country are still reeling with the financial challenges caused by the decline in receipts that occurred when they elected to voluntarily close their offices to help curb the spread of COVID-19. Many dentists are still navigating difficult decisions to support their patients, staff, and small businesses while weighing the uncertainties associated with reopening and providing care.
