Chairman Barrasso, Ranking Member Carper, and members of the Senate Environment and Public Works (EPW) Committee, thank you for providing the opportunity to submit written stakeholder comments to support the committee's "Information-Gathering Process on Draft Legislation entitled, America's Water Infrastructure Act of 2020 and The Drinking Water Infrastructure Act of 2020: Stakeholder Comments."

On behalf of the Academy of General Dentistry (AGD) and its 39,000 members, I would like to thank you for your efforts to develop and consider these discussion drafts. AGD appreciates the EPW Committee's commitment to enriching the lives of so many Americans via improvements to our nation's water resources infrastructure and drinking water infrastructure.

AGD is a professional association for general dentists from across the United States. Founded in 1952, the AGD has grown to become the country's second-largest dental association, and it is the only association that exclusively serves the needs and represents the interests of general dentists. The organization also works to promote the oral health of the public and to foster general dentists' continued proficiency through quality continuing education.

As dentists, we work to ensure that people in communities we serve are able to access safe, clean, and appropriately fluoridated drinking water. The provisions you have incorporated within American's Water Infrastructure Act of 2020 (AWIA 2020) and The Drinking Water Infrastructure Act of 2020 will meaningfully advance this goal in every state, especially in small and rural communities. Small and rural water utilities are often in greatest need of funding assistance for operating, maintaining, and improving their drinking water systems.

The current COVID-19 crisis is placing a substantial financial impact on drinking water utilities¹, many of which were already in dire need of funding to sustain infrastructure and facilities. Delay, prevention, or suspension of community water treatment plans as they relate to water fluoridation will likely result from impending budgetary constraints, intensified by the current crisis.

Community water fluoridation is one of the most practical, cost-effective, equitable, and safe measures communities can take to prevent tooth decay and improve their oral health. Water fluoridation is the best method of delivering fluoride to all members of the community, regardless of age, education, income level, or access to routine dental care.

The benefits of fluoride's effectiveness extend throughout life, resulting in fewer and less severe cavities. Each generation born since the implementation of water fluoridation 75 years ago has enjoyed better dental health than the generation that
