## VISA/MASTERCARD INTERCHANGE FEE CLASS ACTION SETTLEMENT \$5.54 Billion Available

Visa, Mastercard, and the Defendant Banks have reached a settlement, which arose from claims that merchants paid excessive interchange fees for accepting card payments. Although the claim forms are not yet available, you can engage MCAG now to ensure that a proper and timely claim is filed on behalf of your organization.

- **August 2024:** Claim forms have been mailed and available online since **December 2023**. Act promptly, as the deadline to file a claim is **February 4, 2025**. By registering with MCAG, their experts will review the figures supplied by the administrator, as well as all other available data, ensuring you receive every dollar entitled to you under the settlement.

Excessive interchange fees paid by merchants for accepting Visa and Mastercard payments.

Merchants must submit a claim into the settlement, or have a claim submitted on their behalf, to be eligible to receive any cash from the \$5.54 billion settlement fund.
